CLERY ACT DEFINITIONS

Domestic Violence

Domestic violence is a pattern of behavior that includes but is not limited to: physical, sexual, psychological, or emotional abuse by a current or former intimate partner, family member, or household member. This includes threats, harassment, stalking, and the use of force to cause physical injury or fear.

Stalking

Stalking is a course of conduct involving repeated or continuing unwanted contact that causes a person to feel harassed, intimidated, or fearful for the safety of themselves or a family member.

Liquor Law Violation

Liquor law violation refers to the illegal possession, sale, or consumption of alcoholic beverages, including public intoxication and driving under the influence.

Drug Law Violation

Drug law violation includes the possession, distribution, or use of controlled substances, such as marijuana, cocaine, or prescription drugs without a valid medical prescription.

Illegal Weapons Possession

Illegal weapons possession is the carrying or possession of a firearm, knife, or other dangerous weapon in a prohibited location, such as a school or public place.

Larceny-theft

Larceny-theft is the unlawful taking and carrying away of someone else's property with the intent to permanently deprive the owner of it.

Simple Assault

Simple assault is an intentional or recklessness act that causes another person to believe they are in imminent danger of being physically harmed.

Intimidation

Intimidation is the use of threats or force to cause another person to act against their will or to fear for their safety.

Destruction/damage/vandalism of property

Destruction/damage/vandalism of property is the intentional or reckless destruction, damage, or defacement of another person's property.

CLERY ACT DEFINITIONS

CLERY ACT GEOGRAPHY

On Campus

- ▶ **On Campus** means any building or property owned or controlled by an institution of higher education, whether the building or property is located on the institution's campus or not, that is used in whole or in part for the institution's educational, administrative, or financial activities.
- ▶ **On Campus** does not include any building or property that is owned or controlled by an institution of higher education but is used only for religious, social, recreational, or business purposes.

Noncampus Building or Property

- ▶ **Noncampus Building or Property** means any building or property owned or controlled by an institution of higher education, whether the building or property is located on the institution's campus or not, that is used in whole or in part for the institution's educational, administrative, or financial activities, but is not used for the institution's educational, administrative, or financial activities.
- ▶ **Noncampus Building or Property** does not include any building or property that is owned or controlled by an institution of higher education but is used only for religious, social, recreational, or business purposes.

Public Property

- ▶ **Public Property** means any building or property owned or controlled by a state or local government, whether the building or property is located on the institution's campus or not, that is used in whole or in part for the institution's educational, administrative, or financial activities.
